# **Cookie Statement Binadit BV**

#### 1. Introduction

This Cookie Statement explains how and why Binadit BV ("we", "us", or "our") uses cookies and similar technologies on our website [binadit.com] (hereinafter referred to as the "Website"). We believe it is important to respect your privacy and to be transparent about our use of cookies.

#### 2. What are Cookies?

Our Website uses cookies. A cookie is a small text file that is sent along with pages of this Website and stored by your browser on your computer, tablet, or mobile phone. The information stored in the cookie can be sent back to our servers on a subsequent visit. Cookies help us to recognize you when you revisit our Website, for example, by remembering your settings or preferences.

The term "cookies" in this statement also covers similar technologies such as scripts, web beacons, pixels, and other methods to collect information from users via the website(s) or app(s).

## 3. What Types of Cookies Do We Use and Why?

We use different types of cookies for various purposes. Below is an overview of the cookies that may be placed:

#### Necessary (Essential) Cookies:

- Technical Cookies: These cookies are essential for the proper functioning of our Website and the services you request. They enable basic functionalities like page navigation, session management, authentication, security, language preferences, or shopping cart functionality. Without these cookies, the Website cannot function correctly. You cannot refuse these cookies.
- Functional Cookies: These cookies remember your preferences and settings to enhance your user experience. For example, they might remember your language choice, region, or the contents of your shopping cart.

### Analytical Cookies:

- These cookies help us understand how visitors interact with our Website by collecting and reporting information anonymously<sup>1</sup> (or with minimal privacy impact). We use this data to analyse aspects such as which pages are most popular, whether visitors encounter errors, and how long they stay on a page. This helps us to optimize our Website and make it more user-friendly.
- For analytical cookies that have little or no impact on your privacy, we do not need your prior consent, but we will inform you about their use. For analytical cookies that may have a more significant privacy impact, we will ask for your consent.
  - [Example: We use [Name of Analytics Tool, e.g., Matomo with IP anonymization, or Google Analytics with appropriate privacy settings] for analytical purposes. The information collected includes [list specific data

# Marketing or Tracking Cookies:

# 5. Purposes for Placing Cookies

We place cookies for the following main reasons:

- To ensure the proper functioning of the Website.
- To collect (anonymized) visitor statistics to improve our Website.
- To optimize our marketing activities and show you relevant advertisements (with your consent).
- 6. Managing Your Cookie Preferences: Refusing, Deleting, and Setting Cookies When you first visit our Website, we will ask for your consent to use non-essential cookies via a cookie banner or pop-up.

• Impact of Refusing Cookies: If you refuse or delete all cookies, including necessary cookies via your browser, some parts of our Website may not function optimally or at all. Functional cookies ensure a better user experience.

7. On Which Websites/Apps Are Cookies Placed?

The cookies described in this statement are placed when you visit:

8. How Long Do Cookies Remain on Your Device?

The duration a cookie remains on your device depends on whether it is a "session" cookie or a "persistent" cookie.

- **Session cookies** are temporary and<sup>3</sup> only exist for the duration of your visit to the Website. They are deleted once you close your browser.
- **Persistent cookies** remain on your device for a set period specified in the cookie, or until you manually delete them. They are activated each time you visit the Website that created that particular cookie.
